HEIPA REGULAR MEETING MINUTES

CALL TO ORDER

Present: 28 members signed in. See sign in sheet.

Chairman Merlin Jay Renville called the meeting to order at 11:06am.

CHAIRMAN MERLIN JAY RENVILLE'S REPORT

There was a discussion of tribal employees being let go at SWC because of at will employment. Heipa college board representative was not present today. Buffalo lake district voted in a member, but the college won't seat them. SWC charter.

The election board had court on October 5, 2022, for the treasurer position but candidate Michelle Wanna did not appear. A motion was made to accept Erin Kiyukanpi as the interim district treasurer.

Angie Johnson's home repair program – only enough to fund 30 homes and requested more funds from Council out of ARPA funds. There is a request for 2 million dollars for 2023-2024 to go towards home repair and rental assistance.

The election board requested to move the polling location for the November 8, 2022 election to St. Kateri's for more voter turnout.

There was a discussion on building a water tower for the jail infrastructure. The membership requested paper report and updates on who is hired for it and where they are at in the process.

Housing policies and procedures were passed out for the membership last month.

We are waiting on Council for a District Days decision. There were two options suggested at the October 6, 2022, Heipa Executive Meeting. College students, incarcerated, sick in the hospital, military, and those in treatment will only receive the District Portion of \$300.

There has not been a confirmed group to do the District Audit yet. The Watertown group has not replied with an answer if they will do the audit.

- **Motion 3** by Bob LaFromboise, second by Alan LaBelle, question by Doug Renville for Council to allocate another 2 million dollars per year for 2023-2024 to Angie Johnson's Homeowners Program for home repair. 15 for, 0 opposed, motion passed.
- **Motion 4** by Joey Heminger, second Barb Heminger, question Elly LaBelle to have the election polling station at St. Kateri's in Sisseton for the November 8, 2022 election. 13 for, 6 opposed, motion passed.
- **Motion 5** by Tammie Dumarce, second Helena LaBatte, question Elly LaBelle for option one for district days: \$300 per person must be present at the designated distribution center. To include college students, incarcerated, sick in the hospital, military, and those in treatment (must provide documentation). 17 for, 1 opposed, motion passed.

VICE-CHAIR KAREN WHITE'S REPORT

There was a discussion on when the Treatment Center would be finished and the feasibility of it. There are concerns about the type of treatment and what is used for the different addictions people have and having long enough treatment programs.

Discussion of Robert's County Officers overstepping their jurisdiction on tribal and trust land. This jeopardizes Tribal Sovereignty and goes against rights.

Erin Kiyukanpi was sworn in as interim Heipa Treasurer.

Motion 8 by Tammie Dumarce, second Joey Heminger, question Barb Heminger to reaffirm district motion for the removal of Chief of Police Gary Gaikowski. 18 for, 0 opposed, motion passed.

COUNCILWOMAN GYPSY WANNA'S REPORT

Councilwoman Gypsy Wanna gave her report on tours of Flandreau's medical marijuana facility and their newly built nursing home.

There was a discussion on IHS, dialysis, trained technicians, and new forms of treatment. IHS should have a biomed person for medical equipment. Council woman is advocating for better options, treatments, and services. There is concern for funding and which departments these would fall under.

Discussions

There is concern with Elderly Days for unfair treatment and double standards with bringing ID, tribal certificates, and power of attorney papers. A member had

difficulty picking up her daughter's elderly monies and another tribal member had trouble picking up his wife's elderly monies while another person was able to pick up her mother's elderly monies with no papers.

People are still waiting for Housing to repair homes for doors, stoves, refrigerators, etc. Housing road was given the wrong sign, Keeble Circle was given the sign Keoke.

There was discussion on school clothes and which ages are given assistance and which guidelines the district follows. We need to get the Tribe's policies and procedures for school clothes.

There were complaints of using the district van for youth trips.

Motion 15 by Barbara Heminger, second Katherine Wanna, question Elly LaBelle to pay all district youth head start through 12th grade who apply by the deadline of October 21, 2022, for school clothes regardless of age. 14 for, 0 opposed, motion passed.

Motion 16 by Katherine Wanna, second Barbara Heminger, question Doug Renville to add Erin Kiyukanpi to the signature cards for the bank books. 17 for, 0 opposed, motion passed.

Motion 17 by Katherine Wanna, second Barbara Heminger, question Doug Renville to remove Clarine Dumarce from the signature cards for the bank books. 17 for, 0 opposed, motion passed.
